

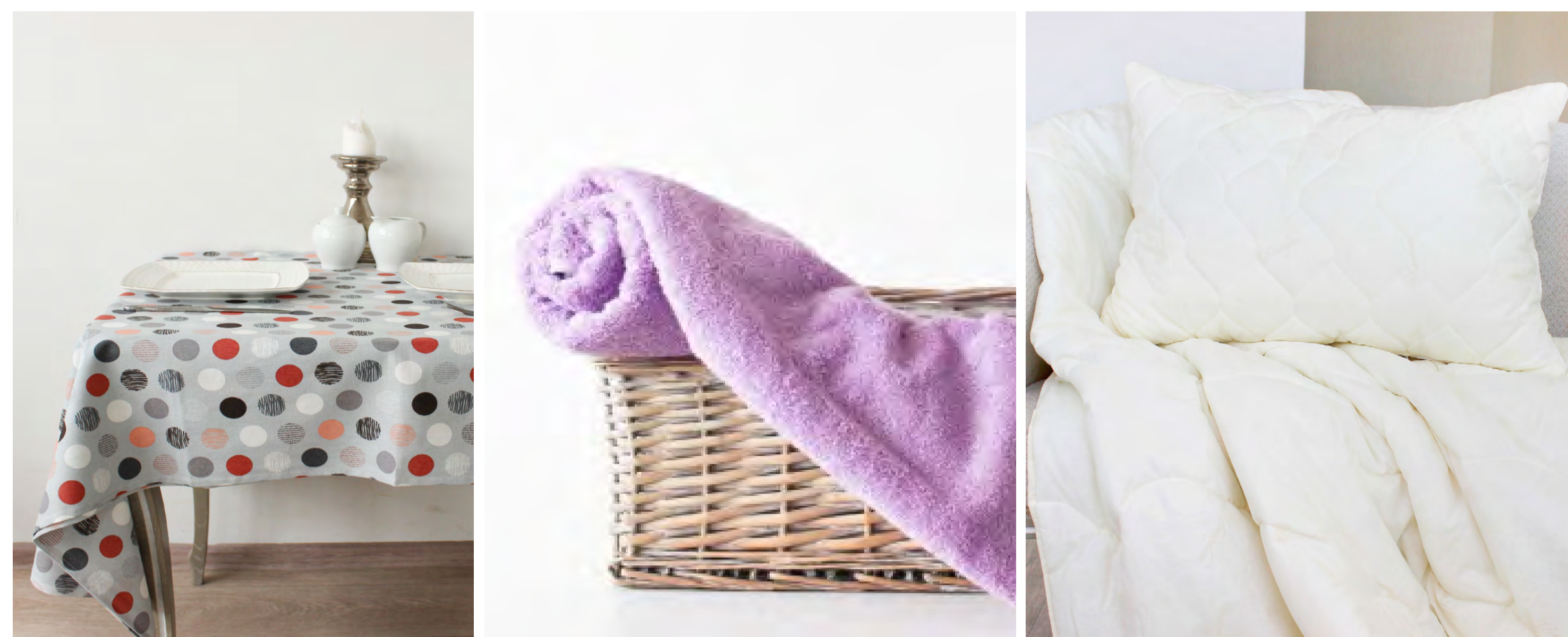
PROJECT DESCRIPTION
